Barksdale, which has \$4.7 billion in assets under management as of September, is 100% employee-owned and 51% woman-owned. Alongside Roberts, other shareholders include Deena Raja, one of the firm's investment grade portfolio managers, and Ellen Carr, the firm's high yield specialist. Operations Manager Kathy Carpenter is a BIM shareholder and has been with Barksdale since its inception.

Rounding out BIM's team of women is Cathy Chamnanphong from the Operations team.

By including women-owned businesses like Barksdale among their suppliers, corporations and government agencies demonstrate their commitment to fostering diversity and the continued development of their supplier diversity programs.

"We hope that our certification will empower other investment management firms to consider diversifying their ownership for the benefit of the clients who have entrusted money to them," Roberts said.
